St. Lawrence University does not tolerate hazing and it is a violation of the Student Code of Conduct, Section 4, Proscribed Conduct. This transparency report is published in accordance with the [Stop Campus Hazing Act \(HR 5646\)](#). Following the initial report published in December of 2025, St. Lawrence will update this report twice a year, August 1 and January 1 of each year. The report will include the current year and the previous 5 years of reported hazing violations.

Personal identifying information for individual students has been removed in accordance with the Family Education Rights and Privacy Act of 1974.

A hazing prevention working group meets to discuss and organize campus prevention and education efforts. We have a thriving theme and club/organization culture and want to emphasize the negative impacts of hazing. Comprehensively, this program emphasizes ethical leadership, positive culture and experiences, positive team building, skill building for bystander interventions, and the importance of reporting and membership accountability.
